# Drainage issues around Marsh Mews

Cllr. Hawkins, Mrs A Bailey and Mr and Mrs Proctor had all attended the Meeting to discuss the ongoing drainage problems on the ground around Marsh Mews. A letter was also received from the occupants of No. 1, Marsh Mews.

Following letter to Dai Larner, Head of Planning, S.M.D.C., with copies to Sybil Ralphs, Leader of the Council, S.M.D.C., Simon Baker, Chief Executive, S.M.D.C. and the Environmental Health Officer, S.M.D.C.

Before the houses were built at Marsh Villa on land belonging to Mr and Mrs Wormold there were no problems with the existing drainage from the Old Police House and Fernlea.

Despite objections from the Parish Council and the District Councillor, the houses now known as "Marsh Mews" were built with no-one taking responsibility for the drainage.

I enclose a letter from the residents of 1, Marsh Mews together with 3 photographs taken of the site.

Members of Rushton Parish Council were absolutely appalled at the state of the drainage and it was a unanimous decision that I should write to you and <u>DEMAND</u> that <u>IMMEDIATE</u> action is taken to rectify this terrible situation.
